All individuals and groups applying for a Special Use Permit will need to complete the attached form and submit it to the Lower Big Blue Natural Resource District.

Organizations with special activities, such as fire arm/archery will also need to provide proof of insurance with the Special Use Permit Agreement.

Once the staff at the Lower Big Blue has reviewed your request, and has determined there is no conflict with prior approved activities, a signed copy of the Special Use Permit will be mailed to the person making the application.

**SPECIAL USE PERMIT AGREEMENT

Willard L. Meyer (Swan Lake) RECREATION AREA**

**Special Use Permit must be completed and returned to the District Office 30 days prior to anticipated event.**

3. The Club shall indemnify and hold the District harmless from and against any and all actions, claims, demands, and damages on the above dates.
4. This permit does not grant exclusive use of the area. Hunting, fishing, camping and other lawful uses are still permitted by the general public and District representatives may enter the area to fulfill responsibilities.
5. This Special Use Permit may be canceled or revoked at any time by the District upon violation of the area regulations, or other just cause.
